'Mr. Big' to get day in court against model who ACCUSED HIM OF ABUSE

OP model Beverly Johnson is headed for a courtroom showdown with two former flames over her claims that they abused her!

The 56-year-old beauty recently filed court papers alleging golf pro Mark Burk beat her and threatened to kill her. Back in 1995, she filed identical charges against her then-boyfriend, "Law & Order" star

But now Burk has slapped Beverly with a lawsuit, claiming she's lying - and is going to subpoena Noth to testify on his behalf.

"Beverly is an unstable woman. She accused me of threatening to slit her throat and slit her dog's throat - which was completely made up," Burk told The ENQUIRER.

"Beverly accused Chris of all sorts of abuse too, but criminal charges were never brought against him. Now he'll be forced to testify against her in my court case, and the truth will finally come out."

Fourteen years ago, we reported that Beverly - who in 1974 became the first

black "Vogue" cover model - accused Noth of beating her, threatening to disfigure her and her dog, and making death threats against her in up to 25 phone calls a day.




Ms. Johnson made back in 1995," Noth said when contacted by The ENQUIRER. "I was approached about Mr. Burk's situation, but I haven't been subpoenaed."

Beverly, who's now judge of the TV show "She's Got the Look," also filed a restraining order against "Sex and the City" star Noth - just as she's done against Burk, 51.

In a recent ENQUIRER interview, Burk claimed Beverly painted her face and neck with makeup to look as if he'd attacked her, took her own photos and presented them to the court as evidence.

"But those were NOT police photos, and we will have expert testimony saying the photos have been doctored," said Burk. "What Beverly has done to me and Chris is unconscionable, but it's all catching up to her."





H, my God, I could lose the baby!" Rihanna has told pals that horrifying thought raced through her mind as her boyfriend Chris Brown brutally beat her – because she thinks she is pregnant, The ENQUIRER has learned.

The talented pop beauty had already told Brown that she might be expecting his baby, and friends fear that may be what triggered his violent rage.

Brown, 19, now faces assault charges for the Feb. 8 attack, but prosecutors are considering adding felony domestic abuse counts and even an attempted murder charge, which could put the R&B singer behind bars for years.

"If Rihanna is pregnant, Chris could have killed the baby," claimed a distressed insider.

Recalling her terror when Brown started pummeling her, Rihanna told friends: "All I could think was, 'Oh, my God, I could lose the baby!""

But Rihanna - who was shown battered and bruised in a leaked police photo – is said to still be too shaken to get a pregnancy test to learn whether she's carrying Brown's baby.

"Rihanna had missed her period and told friends that she thought she was pregnant. But when she told Chris he didn't want to talk about it and was sort of in denial," maintained the insider.
